

**SPORTS PAGE**  
**SKI/SNOWBOARD EQUIPMENT LEASE AGREEMENT**

1. **Lease.** I, \_\_\_\_\_ (“Lessee”) hereby lease from The Sports Page Ski & Patio Shop (“Lessor”), the ski/snowboard equipment (collectively, the "Leased Equipment") more particularly described in the accompanying Invoice/Waiver and Release of Liability Agreement attached hereto and executed herewith.

2. **Cost.** The rental cost for the Leased Equipment shall be \$ \_\_\_\_\_, and is payable upon execution of this Lease Agreement.

3. **Term of Lease.** The term of this Lease extends from the date of execution and continues to until April 30, 20\_\_\_\_. Upon expiration of the lease term, Lessee will return the Lease Equipment in good condition, ordinary wear and tear resulting from proper use of the Leased Equipment alone excepted.

4. **Debit/Credit Card Authorization** In the event that I, the Lessee, fail to return the Leased Equipment specified in the accompanying and aforesaid Invoice/Waiver, and Release of Liability Agreement by April 30, 20\_\_\_\_; or, upon my return of the Leased Equipment specified in the accompanying Invoice/Waiver and Release of Liability Agreement in a damaged condition beyond that of ordinary wear, I, the Lessee and undersigned cardholder, authorize the Sports Page Ski and Patio Shop to charge my debit/credit card number the original lease price as stated in part 2 of the Sports Page Lease Agreement.

5. **Lessor's Expenses.** Lessee shall pay Lessor all costs, disbursements, and expenses, including reasonable attorney's fees, incurred by Lessor in exercising any of its rights or remedies hereunder or in enforcing any of the terms, conditions, and provisions hereof, or in commencing any claim, cause of action, action, or proceeding to recover under this Lease and Debit/Credit Card Authorization.

6. **Indemnity.** Lessee shall indemnify Lessor against, and hold Lessor harmless from, any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including reasonable attorneys' fees, arising out of, connected with, or resulting from the Leased Equipment, including without limitation the manufacture, selection, delivery, possession, use operation or return of the Leased Equipment.

7. **Waiver and Release of Liability.** I, the Lessee, acknowledge that I have read, understand, agreed to, and signed the accompanying Invoice/Waiver and Release of Liability Agreement which is incorporated herein by reference. Furthermore, I verify that I am aware that skiing and/or snowboarding is an inherently hazardous activity involving risk of injury and that I am voluntarily participating in those activities with the knowledge of the danger involved. I also acknowledge and verify that I understand the Leased Equipment has been set and tuned according to my representations of ability, height, weight, and age or according to my representations as to the ability, height, weight, and age of the Authorized User(s)—if applicable. As such, I expressly assume and accept any and all risks associated with the sport of skiing or snowboarding and agree to release the Lessor from any responsibility or liability with respect to the Leased Equipment whether it results from the user of the Leased Equipment listed on the Invoice/Waiver and Release of Liability Agreement, or whether it results from the selection, inspection or adjustments of the Leased Equipment by the Lessor or its employees. Additionally, neither Lessee nor the Authorized User(s) of the Leased Equipment shall permit any individual not listed in this agreement to use the Leased Equipment or any Part thereof without the express written authorization of the Lessor.

8. **Ownership.** The Leased Equipment is, and shall at all times be and remain, the sole and exclusive property of Lessor; and the Lessee shall have no right, title or interest therein or thereto except as expressly set forth in this Lease.

9. **Option to Purchase.** At any time after execution of this Lease Agreement, however, up to and including, but not later than the date on which it expires, Lessee shall have the right, at his or her option, to purchase the Leased Equipment, or any portion thereof, for amounts equal to those described paragraph four (4) above —the Debit/Credit Card Authorization.

10. **Entire Agreement.** This instrument, along with the accompanying Invoice/Waiver and Release of Liability Agreement, constitutes the entire agreement between Lessor and Lessee; and it shall not be amended, altered or changed except by a written agreement signed by the parties hereto.
